## DELAWARE COURTS SUSPEND ISSUING OF FAILURE TO PAY WARRANTS, PROVIDE EMERGENCY DEBT-RELIEF DURING CORONAVIRUS PANDEMIC

News Provided by the Delaware Campaign to End Debtors' Prisons, Network Delaware, ACLU of Delaware and the Delaware Coalition for Smart Justice

**WILMINGTON, DE (April 13, 2020)** -- Delaware State Courts have launched a new policy, in consultation with the Department of Justice, the Office of Defense Services, and other justice partners, to cease issuing capiases, or bench warrants, for failure to pay court debt from approximately March 13, 2020 to a date not yet determined. The Courts' decision comes as a response to the financial impact the novel Coronavirus pandemic has had on Delaware communities, and during the crisis all collection efforts have stopped.

As a part of ceasing the issuing of failure to pay capiases, the State Courts are also ceasing the imposition of late fees and the accruing of interest during this period. In addition, drivers' licenses will not be suspended for unpaid court debt during this time. In 2017, Delaware State Courts issued 44,889 warrants for failure to pay court debt from non-felony offenses, and 20,679 drivers' licenses were suspended for failure to pay court-ordered court debt. "[A]s more Delawareans -- especially those in lower-paying, non-salaried positions -- are impacted by shutdowns and the slowing economy, their ability to meet payments due to the courts will be affected[,]" Karen Lantz, Legal and Policy Director of the American Civil Liberties Union of Delaware, and Margaret Hu, with the Campaign to End Debtor's Prisons explained in a letter.
