Settlement Reached on State Track in Delaware Public Schools Litigation

The settlement terms are an historic step in the right direction on education equity in Delaware.

On Monday, October 12, we, alongside Community Legal Aid Society, and Arnold & Porter, negotiated a settlement on behalf of our clients NAACP and Delawareans for Educational Opportunity and with Governor John Carney on the state track in our landmark lawsuit to ensure



adequate funding for all students in Delaware's education system.

The court approved our settlement, which guarantees the following:

\$25 million

in Opportunity Funding, which was instituted on a temporary basis after the lawsuit was underway, used to enhance services and

provide additional resources to English learners and low income students, will become permanent and more



than double to \$60 million by the 2024-2025 school year. After that, the \$60 million will increase proportionally with student growth.

• Opportunity Funding resources will be allocated specifically to the schools serving English language learners and low income students, in proportion to the number of those students at each school. \$5 million of these funds will be reserved for mental health and reading supports in schools with the highest concentrations of low income and English learner students.

• Funding dedicated to basic special education

Dear Friends and Supporters,

As we end 2020, I cannot help but reflect back on a tumultuous and historic year and feel deep gratitude. This year has had its fair share of challenges, but we have weathered many concurrent storms that have tested our very democracy. Throughout it all, ACLU supporters have been at the forefront fighting for our American ideals of liberty. freedom and equality.

In the midst of a pandemic, a record number of Americans cast ballots in the presidential election. Delawareans had the opportunity for the first time to cast their votes by mail without an excuse, so that no one would have

to choose between their health and right to vote. But simply having the right to vote means little without advocacy and education to ensure everyone can exercise that right. In response to the expansion of vote by mail. the ACLU of Delaware launched a public education campaign that included advertising on social media. creation of a video walking voters through the process of casting a ballot by mail, and advertising in newspapers and radio stations across the First State encouraging people to make a plan to vote.

In partnership with the Votamos We Vote Coalition--a group of nonpartisan, nonprofit Delaware organizations focused on civic engagement and Latinx people, the ACLU of Delaware texted over 10,000 Latinx voters to encourage them to vote. In addition, we partnered with the Delaware Hispanic Commission to host a Spanish language radio show on a popular station in Sussex County to highlight voices from the Latinx community discussing the importance of the November election.

The fight for the right to vote continues beyond a single election. In 2021, we will work with the Delaware General Assembly to make vote by mail a permanent option for all voters, and we will advocate for changes to the voting system to ensure our elections remain safe. accessible and secure. Our country is worth fighting for, and you can count on the ACLU of Delaware to continue to push reforms that ensure every voter can have their voice heard.

students in Kindergarten through 3rd grade to equal funding currently in place for basic special education students in grades 4-12 by the 2023-2024 school year.

• By the 2023-2024 school year, the Early Childhood Assistance Program, which funds preschool programs for low income families, will double its funding from \$6.1 million to \$12.2 million.

• A \$4 million annual commitment to support enhanced teacher recruitment and retention in high-needs schools beginning in the 2022-2023 school year.

• An ombudsperson program will be adopted to assist individual students and families in resolving disputes or complaints concerning disparate discipline, inequitable access to school programs, and different or unfair treatment.

School districts

seeking voter approval for capital construction and major renovations will be required to distribute an equity statement to explain how the capital project would

impact equitable distributions of new and renovated buildings within the district.

• The State will hire an independent organization to complete a holistic assessment of the Delaware public school finance system by January 2024, which shall consider funding levels, revenue mechanisms, equity, and efficiency.

These are historic, systemic changes that will benefit the most vulnerable students.

We are grateful that Governor Carney agreed to increased funding rather than continue protracted litigation. **However**, we know that these changes alone will not fully guarantee equity, and we will continue to press forward with our advocacy on fair discipline, the school-to-prison pipeline, and access to education.

In the county track of this case, we have a tentative trial date at the end of March 2021 to determine the timing and manner of an appropriate remedy for the counties' property tax assessment system that the Court ruled in May violates the Delaware Constitution and state law.

In the meantime, we're preparing for advocacy efforts on education equity throughout



the state as partners in S.A.F.E. (Safe, Accountable, Forward, Equitable) Schools, a Building People Power Initiative. To learn more about this lawsuit or our education equity advocacy efforts, visit www.aclu-de.org.

Wilmington Pases Civilian Review Board in 10-1 Vote

This long-overdue police accountability tool is an important step forward on police reform.

n the wake of horrific acts of police brutality this year, people around the country and here in Delaware have been marching, protesting, organizing, and advocating with a rally cry to bring an end to systemic racism in policing and for police accountability and transparency.

Earlier this year, Wilmington City Council proposed legislation for its own civilian review board, the Wilmington Citizen Complaint Review Board (CCRB). We sent a letter to the city council in support of this proposed ordinance, with some recommendations for making the proposed ordinance even stronger. And when the ordinance came up for a vote, we called on the Wilmington community to make their voice heard and ask their city council members to vote "yes."

On Thursday, November 19, 2020, the Wilmington City Council voted 10-1, with one absent vote, to pass the proposed ordinance that will amend Chapter 35 of the City Code and create a Citizen Complaint Review Board (CCRB) in the city.

Building an effective civilian review board isn't an easy task, but Wilmington City Council's commitment to moving ahead with this kind of police accountability effort is a significant step in the right direction. **TAKE ACTION:** Stand with us to reimagine Delaware's probation system.

s of now, we know the status of two of the three branches of the federal government. We have President-elect Joe Biden in the executive, and an even more conservative majority in the Supreme Court with the appointment of Justice Amy Coney Barrett. The future of Congress is still unknown as we await the results of two runoffs in Georgia that could hand control of the Senate to either party.

Even before the results of those Senate races are in, we know that the fate of civil rights and civil liberties hangs in the balance. Civil rights protections previously defended by a narrow majority in the Supreme Court could be in jeopardy. At the same time, the Biden administration will have the opportunity to roll back Trumpera assaults like the Muslim ban; it might also get a chance at its own appointments.

On a recent episode of At Liberty, ACLU National Legal Director David Cole helps us to understand and forecast the impact of a Biden presidency and the most conservative Supreme Court in more than half a century.

Overhauling Our Immigration System Begins with Citizenship for All

s we approach the end of President Trump's first term, it's important to understand why and how he has inflicted such damage on our nation's immigration system and advanced his anti-immigrant, racist agenda. Trump has been able to systematically undermine our immigration laws and principles of fundamental fairness because our immigration system is fundamentally broken. It has been for decades.

So, what's next? How do we move forward when the damage is so sweeping?

An inclusive pathway to citizenship for the estimated 11 million undocumented and stateless people living in the United States — without caveats or tradeoffs — is the first move. Citizenship for these 11 million people would mean that no president could rip the rug out from underneath more than 700.000 Deferred Action for Childhood Arrivals (DACA) recipients, 320,000 Temporary Protected Status (TPS) holders, or the millions of long-time residents

whose lives and status have come to depend on who is in the White House. It would also mean that federal lawmakers across the political spectrum could no longer use undocumented and stateless immigrants as leverage for justifying even more enforcement.

As our nation reckons with our legacy of white supremacy, providing full citizenship to millions of Black and Brown immigrants is critical to realizing the promise our nation has yet to deliver, despite exploiting their labor for generations. In



spite of this history, immigrants continue to step up as essential workers, working on the front lines of this pandemic and risking their lives to protect our loved ones and communities.

Nationwide, there are approximately 19.8 million "essential" immigrant workers, risking their lives under the constant threat of exposure. There are 1.7 million immigrant medical and health care workers caring for COVID-19 patients, and 27,000 DACA recipients working as doctors, nurses and paramedics. Undocumented immigrants pay billions of dollars in federal taxes each year, and yet have been inexplicably left out of COVID-relief packages. Immigrants are essential, now and for years to come — they are part of our communities, our families, and our shared history.

We need a clean, inclusive pathway to citizenship that doesn't include more tradeoffs and doesn't scapegoat immigrants deemed less than deserving. Because "we the people" means all of us, regardless of immigration status.
