DELAWARE STATE SENATE 151st GENERAL ASSEMBLY

SENATE BILL NO. 111

AN ACT TO AMEND TITLE 10 AND TITLE 11 OF THE DELAWARE CODE RELATING TO AUTOMATIC EXPUNGEMENT.

BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF DELAWARE:

1 Section 1. Amend Part A, Subchapter III, Chapter 9, Title 10 of the Delaware Code by making deletions as shown 2 by strike through and insertions as shown by underline as follows: 3 § 1017A. Mandatory expungement; automatic. 4 (a) A case that is eligible for mandatory expungement under § 1017 of this title is eligible for automatic 5 expungement under this section. 6 (b) Beginning August 1, 2024, on a monthly basis, the State Bureau of Identification shall identify cases that are 7 eligible for mandatory expungement and proceed under § 1019 of this title to expunge the eligible records. 8 (c) The Department of Safety and Homeland Security may promulgate reasonable regulations necessary for the 9 State Bureau of Identification to accomplish the purposes of this section. 10 (d) Nothing in this section precludes an individual from filing a petition for expungement of records under § 11 1017(a) of this title that are eligible for automatic expungement under this section if an automatic expungement has not 12 occurred. 13 (f) An individual does not have a cause of action for damages as a result of the failure to identify an individual's 14 case as eligible for automatic expungement. 15 Section 2. Amend § 1019, Title 10 of the Delaware Code by making deletions as shown by strike through and 16 insertions as shown by underline as follows: 17 § 1019. Effect of expungement; disclosure of expunged records. 18 (a) The Court shall notify the State Bureau of Identification (Bureau) of any expungement order. If an order

expunging part or all of a juvenile criminal history is granted by the court, all indicia of arrest, including police and court

records and any electronic records relating to the arrest, and any other items specified in the order shall, within 60 days of

receipt of the order, be removed from the files and placed in the control of the Supervisor of the State Bureau of

Identification who shall be designated to retain control over all expunged records, and who shall insure that the records or
the information contained therein is not released for any reason except as specified in this subchapter. A court or police
agency that receives a notice of expungement from the State Bureau of Identification shall provide the Bureau with written
confirmation of the completion of the expungement. The State Bureau of Identification shall provide the court that entered
the order with written confirmation of the execution of the order. In response to requests from nonlaw-enforcement officers
for information or records on the person who was arrested, law-enforcement officers and departments shall reply, with
respect to the arrest and proceedings which are the subject of the order, that there is no record. No order requiring an
expungement of any record shall be entered or enforced if such order is contrary to the provisions of this subchapter. The
State Bureau of Identification shall promptly notify the court if it is unable to comply with any order issued pursuant to this
subchapter.
(j)(1) If the State Bureau of Identification determines that expungement is mandated under this subchapter, or
receives an expungement order from a court, it shall promptly notify all courts and law-enforcement agencies where records
pertaining to the case are located or maintained, and any court where the case was terminated, disposed of, or concluded.
(2) A court or law-enforcement agency which receives a notice of expungement from the Bureau shall provide
the Bureau with written confirmation of the completion of the expungement. Where an expungement of an adjudication
of delinquency is granted, all arrest records associated with any charge in that case must also be expunged.
Section 3. Amend Subchapter VII, Chapter 43, Title 11 of the Delaware Code by making deletions as shown by
strike through and insertions as shown by underline as follows:
§ 4373A. Mandatory expungement; automatic.
(a) A case that is eligible for mandatory expungement under § 4373 of this title is eligible for automatic
expungement under this section.
(b) Beginning August 1, 2024, on a monthly basis, the State Bureau of Identification shall identify cases that are
eligible for mandatory expungement and proceed under § 4372(e)(2) of this title to expunge the eligible records.
(c) The Department of Safety and Homeland Security may promulgate reasonable regulations necessary for the
State Bureau of Identification to accomplish the purposes of this section.
(d) Nothing in this section precludes an individual from filing a petition for expungement of records under §
4373(a) of this title that are eligible for automatic expungement under this section if an automatic expungement has not
occurred.
(e) An individual does not have a cause of action for damages as a result of the failure to identify an individual's
case as eligible for automatic expungement.

- 52 Section 4. This Act is effective immediately and is to be implemented on August 1, 2024.
- Section 5. This Act is known as "The Clean Slate Act".

SYNOPSIS

This Act creates an automatic expungement process for adult and juvenile charges that are eligible for mandatory expungement because under the petition-based system, only a small fraction of people eligible for expungement ever obtain this important relief. Under this Act, the State Bureau of Identification must identify and expunge cases eligible for automatic mandatory expungement on a monthly basis.

This Act is effective immediately and will be implemented on August 1, 2024. Implementing the automatic expungement process requires coordination between different courts and state agencies.

This Act is known as "The Clean Slate Act".

This Act also makes technical corrections to conform existing law to the standards of the Delaware Legislative Drafting Manual.
