# **Delaware Begins the Journey to Smart Justice**

We're tackling mass incarceration piece-by-piece until the prison population is cut in half.

he Campaign for Smart Justice has two major goals: cuting the prison population by half and challenging the racial bias in our criminal justice system. To succeed, we're creating a strong grassroots movement that clearly articulates and demands change. In order to see that change through, we also need to elect reform minded candidates who share our goals, including Delaware's next Attorney General and members of the General Assembly.

### The Problem

The United States has only 5 percent of the world's population— yet we account for 25 percent of the world's prison population. Every state in America contributes to our incarceration rates and Delaware is no exception.

Despite our small size, Delaware incarcerates at a rate higher than the national average and all our surrounding states. Our incarceration rate is 81 percent higher than New Jersey's and 79 percent higher than New York's.

Mass incarceration is fueled. in part, by the identity of those most impacted by the system. In Delaware, African Americans are 22 percent of the population, but they make up 51 percent of our prisoners. This disproportionate number is a direct result of the racial bias that runs deep in our criminal justice system—from the way we police to the way we prosecute to the barriers preventing successful reentry after someone has served their time.

### The Campaign

Our aim is to educate the public about the staggering number of Delaware residents who have been adversely CONT. ON PAGE 3

### **Executive Director's Notes**

A Focus on Our Partnerships

he Campaign for Smart Justice is such an exciting project. The goal of cutting the prison population in half and challenging the racial bias in the criminal justice system is ambitious and inspiring. I say, it's about time that we, as a state and a country, push back hard on the tough-on-crime approach to public policy that we've been living with since at least the 1980's. Years of research show that keeping low-level offenders out of prison and providing shorter sentences and high-quality education and job training for those we do send to prison are the keys to a safer community.

To succeed with a project like this, we need strong allies. I know that working with Network Delaware. Metropolitan Wilmington Urban League, Delaware Center for Justice, Coalition to Dismantle the New Jim Crow, Delaware United and others establishes a strong foundation from which to operate. I'm especially looking forward to the launch of the People's Platform Project—a collaboration between ACLU-DE. Network Delaware and the Urban League that will put a team of four organizers in the field to promote smart justice, education justice and economic justice policy reform.

The People's Platform organizers will build teams of concerned constituents in critical legislative districts. These teams will make sure that their neighbors are educated about the issues, registered to vote, and that they get out to vote for the primary election on

September 6th and the general election on November 6th. This essential project will help

us build a team of citizen lobbyists, gain influence in Legislative Hall and provide support for the significant change that is needed to bring justice to all Delawareans.

Before I sign off, I want to recognize three board members who have just moved off of our board of directors: George Meldrum, a senior policy analyst for the Nemours Foundation, who had only been with us for a few years but was always willing to help with our fundraising efforts; Norm Monhait of Rosenthal. Monhait and Goddess P.A. who served for over 30 years on the board and always provided wisdom and insight no matter the subject; and Helen Foss, who retired in 2000 after a long and significant career in the education field. Helen also served on the board for over 30 years and was our institutional memory in all things related to education. The ACLU of Delaware, and I personally, cannot thank these three enough for their dedication to this organization and our shared values of liberty and justice. You will be missed!

affected by the criminal justice system and how that system disproportionately impacts people of color.

A goal like ending mass incarceration is an ambitious one, but we're up for the challenge. Through public education, grassroots organizing and legislative advocacy, we will challenge the system and create change for individuals, families and communities. We're tackling every piece of the puzzle:



**Sentencing Reform:** Reduce both the number of people entering prison and the laws and policies that drive extraordinarily long prison sentences.



**Eliminate Money Bail:** Eliminate the unjust and for-profit bail system that targets poor people and people of color and hurts families and communities.



**Prosecutorial Reform:** Delaware's Attorney General is our state's only elected prosecutor. Prosecutorial reform must start with an attorney general dedicated to change.




**Parole Reform:** Ensure systems are fair, respect people's rights and promote safety and success for those returning to their communities.



**Reentry:** Eliminate the barriers that hold back people living with a criminal record and expand reentry programming.

Smart Justice in Delaware means reducing the size of our prison population so that more resources can be devoted to high quality programs inside and outside of prison. It also means dismantling criminal justice approaches that have proven to be racially biased, ineffective and crippling to the future of our society. To do this, we must elect a reform minded



Attorney General and members of the General Assembly. That's why we are targeting the upcoming 2018 primary and general elections with the aim of educating Delawareans on the policy changes that will have a significant impact and motivating them to vote for reform minded candidates.

97 percent of criminal cases in Delaware are

settled with a plea deal. That means most often the prosecutor, not the judge, has the greatest impact on who goes to prison and for how long. In Delaware, the chief prosecutor is the Attorney General—the only law enforcement official elected by the voters and the one in charge of all the professional career prosecutors who work for the Department of Justice.

We submitted a candidate questionnaire to all of the Attorney General candidates to get a clear understanding of where they stand on our

## An Update on Our School Funding Lawsuit

Delaware doesn't think that our constitution requires effective schools

very child deserves a chance to succeed. That's why we filed a lawsuit against the state in January—to try to get effective schools for all of Delaware's children. In April, the state filed motions to dismiss the case. We filed our opposition brief to those motions on May 22.

Our case is strong. The Delaware Constitution requires effective schools and it is the role of the court to ensure that the constitutional commitment is being met. This lawsuit is important because many high poverty schools in both rural and urban areas are receiving fewer resources per student than schools with students who are better off. As a result, low income students, English language learners and students with disabilities are being left behind.

Next, defendants will submit a final reply brief, and then it will be in the hands of the Court of Chancery to decide whether our case should proceed on its merits. We'll keep you updated on progress. To read any of the briefs in this case, please go to our website.

### People Power Builds Up to Tackle Voting Rights

It's time for efficient, accessible and secure voting in Delaware.

The right to vote, and to have one's vote accurately and fairly counted, is a fundamental right of all Delawareans. That's why we're coordinating the People Power effort in Delaware by facilitating meetings, offering support and resources, and focusing on voting and voting rights in the First State.

Often, the flaws in the voting system disproportionately affect people of color and alienate already marginalized communities from the voting process, which leads to an inaccurate democratic representation of the First State.

The "Let People Vote" campaign in Delaware has a few main focuses:

- Getting new voting machines;
- Supporting legislation that removes the barriers to voting; and
- Getting out the vote.

We need your help to break down the barriers to voting and make our democracy inclusive, accessible, secure and efficient.
