Dear Friends,

There's no other way to say it: the U.S. Supreme Court has declared open season on some of our most fundamental rights.

Their decision in Dobbs to overturn nearly five decades of precedent affirming every person's right to abortion is a travesty. We expect 26 states to ban or severely restrict abortion immediately, with other states to potentially follow. While Delaware has protected abortion

rights, bans in other states will undoubtedly impact the First State's healthcare system.

But it's not just abortion rights in the crosshairs-the Court issued opinions this term that curtailed our rights when stopped by the police, the separation of church and state. and our right to fair and proportional representation. In Justice Thomas' concurring opinion in Dobbs, he outright called for the Court to overturn other historic precedents protecting rights to contraception,

marriage equality, and same-sex relationships.

This tectonic shift in the Court demonstrates the need for the ACLU to work not just through litigation, but through organizing, advocacy, lobbying, and public education. Liberation will not come solely through the courts, but through integrated campaigns that build power to affect change. The path forward is not an easy one, but it is one that we can navigate together. 🔤

Voter Engagement

Avenues for engagement will help Delaware take steps toward combating voter suppression and increasing voter participation.

One of the largest populations prevented from engaging in elections are justiceinvolved individuals. Ending felony disenfranchisement and allowing eligible incarcerated voters to cast ballots remains a campaign priority. In Delaware, thousands of justiceinvolved people are disenfranchised every election. Many more are disenfranchised because the rules and regulations around voting eligibility are confusing and cumbersome. Our campaign is actively working to dismantle barriers to prison voting and support the expansion of voting eligibility for those with felony convictions.

Elections and Candidate Information

Through our voter education website, VoteDelaware.org, we're compiling everything Delaware voters need to know to make their plan to vote. In addition to information on registration, dates, deadlines, alternative methods of voting. and voter assistance. VoteDelaware. org helps Delaware voters learn about our priority issue platforms. VoteDelaware.org also features our 2022 Candidate Questionnaire. designed to help voters find out where their candidates stand on the issues they care about.

Our democracy is stronger and more sustainable when voting is easy, encouraged, and expanded.

The ACLU Voter Campaign is dedicated to advocating for solutions that allow every eligible Delaware voter an accessible way to engage in the voting process. The freedom to vote will always be the fundamental right upon which all our civil liberties rest.

New Lawsuit: FCANCER Vanity License Plate Censorship

n response to additional plaintiffs speaking out on allegations of abuse experienced at Sussex Correctional Institution (SCI), the ACLU of Delaware and Whiteford Taylor Preston (WTP) have filed a second amended complaint in the litigation.

The amended complaint included details from plaintiffs that allege even more violent and targeted attacks on people serving time at SCI as well as serious concerns about retaliation against named plaintiffs.

This litigation is ongoing, and significant updates will continue to be released to media and the public as they happen.

n 2020, Delaware resident Kari Lynn Overington reserved a vanity license plate for her vehicle, which she received in 2021. After a grueling battle with breast cancer, this vanity plate was a victory statement about her fight with cancer: FCANCER.

In June 2021, the Delaware Division of Moter Vehicles (DMV) sent Kari a letter recalling the license plate because "it does not represent the division or the state in a positive manner." Over the course of several weeks, Kari attempted to advocate with state officials to allow her to use the FCANCER license plate, but to no avail.

"As a cancer survivor, the fight to end cancer is extremely personal to me," said Ms. Overington. "I was shocked when the DMV recalled my license plate because fighting cancer in our communities is imperative, and a message I assumed everyone would embrace."

After getting nowhere by advocating for herself with DMV officials, Kari decided to take the fight to court — without legal representation — citing that the censorship of her license plate violated her right to free speech.

In August 2022, a federal judge in the U.S. District court denied the State's motion to dismiss the lawsuit, saying that the case raises "a significant constitutional issue."

Now, we're stepping in. The ACLU of Delaware will help Kari see the rest of this lawsuit through. Legal Director Dwayne J. Bensing will be the primary attorney representing Kari Overington in her case moving ahead.

movements' success which is an important shift if we are going to remove patriarchy, classism, white supremacy and other structural oppressions from the philanthropic landscape.

First State Abortion Fund, Delaware NOW (National Organization for Women), Black Mothers in Power, the Southern Delaware Alliance for Racial Justice, and Women's March Sussex.

The Helpline will provide free legal advice to anyone in need of guidance after the Supreme Court's June *Dobbs* decision, including.


